

## **REGULAR MEETING, TOWN OF LIVONIA**

August 14, 2014

A regular meeting of the Town Board of the Town of Livonia, County of Livingston and the State of New York was held at Vitale Park, Lakeville, NY on August 14, 2014.

The meeting was called to order by Supervisor Gott at 7:00 PM.

The Pledge was led by Doug Grouse.

### **PRIVILEGE OF THE FLOOR**

#### Lakeville Sanitary Sewer Overflow

A resident who lives on Big Tree Road near the pharmacy raised concerns about the sewer system in that area. He stated that during the heavy rain events this year, the sewers overflowed and raw sewage was in his yard and some of the neighbors' yards. Although the Livingston County Water and Sewer Authority was very responsive, he wanted to know what is going to be done to prevent this from happening again.

Supervisor Gott replied that although the town is not in the water and sewer business he has had a meeting with the Livingston County Water and Sewer Authority to discuss this issue. He directed the resident to the Livingston County News article that reported on the meeting. Supervisor Gott has sent letters to our representatives – Bill Nojay and Catherine Young – to see if there is any grant money available to help with this problem.

Supervisor Gott said that the problem is getting better, thanks to the efforts of the Water and Sewer Authority, but more still needs to be done. One possible solution is to install a large holding tank, which would handle the excess volume during storm events until the water could be treated, but that is very expensive. The Water and Sewer Authority has been smoking the system and using a robotic camera to identify where people have connected their gutters and sump pumps into the sanitary sewer system. When those illegal connections are found, the homeowners are notified and made to rectify the situation. Supervisor Gott offered meet with the Big Tree Road residents and the Water and Sewer Authority to answer their questions and address their concerns.

#### Federal Road Speed Limit

A resident of Federal Road raised concerns over the speed limit on Federal between Big Tree Road and Cadyville Road. Supervisor Gott reported that we have asked for a speed limit

reduction in that area several times and have been turned down each time. He is willing to bring it up again, if the resident would like and if the board is in agreement. The board agreed, and Supervisor Gott asked the resident to bring him a list of the neighbors' names, addresses, and concerns.

Road Shoulder

A resident reported that the shoulder of Poplar Hill Road near Councilmember Grouse's home is washed away. He asked if the county was going to fix it, or is that something the Town Highway Superintendent should be made aware of. Supervisor Gott answered that it is a county road, and the county will fix it. They have had a lot of work to do after all the recent storms.

Breakwall at Vitale Park

A resident asked for an update on breakwall repairs at Vitale Park. Supervisor Gott answered that he has a meeting with the Town Engineer on Thursday next week at 3 PM to discuss the breakwall. Board members are invited to attend if they are able.
