WHEREAS, the housing crisis has negative effects at regional and local levels, we believe that every community must do their part to contribute to housing growth and benefit from the positive impacts a healthy housing market brings to communities; WHEREAS, we believe that supporting housing production of all kinds in our community will bring multiple benefits, including increasing housing access and choices for current and future residents, providing integrated accessible housing options that meet the needs of people with sensory and mobility disabilities, bringing economic

opportunities and vitality to our communities, and allowing workers at all levels to improve their quality of life through living closer to their employment opportunities; WHEREAS, we believe that evidence showing that infill development that reduces sprawl and supports walkable communities has significant environmental and public health benefits; and

WHEREAS, we believe that affirmatively furthering fair housing and reducing segregation is not only required by law, but is essential for keeping our community strong and vibrant:

NOW, THEREFORE, IT IS HEREBY RESOLVED that the Town of Livonia, in order to take positive steps to alleviate the housing crisis, adopts the ProHousing Communities pledge, which will have us endeavor to take the following important steps:

1. Streamlining permitting for multifamily housing, affordable housing, accessible housing,

accessory dwelling units, and supportive housing.

#### DISCUSSION ON LITTLE LAKES COMMUNITY CENTER PARKING LOT

Maryann Thompson presented and thanked the Board for their past support and states she will try to be more vigilant about keeping them up to date. There have been a lot of accomplishments at the Little Lakes Community Center. To name a few-a new roof, the windows glazed and re-painted, pickle ball, music jams, and acts of hope. Over 200 people have joined their team reach app. This winter, starting back in November, they opened the doors to Livonia travel basketball teams. There are also karate classes and 8 business' in the building. MaryAnn expressed her gratitude to the volunteers that are working together to make this such a vibrant place to be. She asked if the Town would consider offering any assistance in re-paving the parking lot. Supervisor Gott advised that Highway Superintendent Paul Dwyer contacted Jim about this request previously and if he remembers correctly that it was not appropriate to use excess resources from the Town.

#### **DISCUSSION ON WATER DISTRICT**

Nothing to report-petitions have been turned in and will be reviewed after the petition period ends which is tomorrow 2/21/25. If this project moves to a vote then the Board will take the steps necessary to do so. A resident asked if people who already have water that are in the proposed district as a "0" unit have signed the petition, if their signature will count or not.

Janice Quinn submitted a letter to the Town Board members. Supervisor Gott advised that the Board has discussed having an outside organization put together communication to everyone in the proposed district to avoid any further miscommunication.

Another resident asked if it could be done in the form of a mailer. This has been strongly considered by the Town Board.

Another resident asked if people who are within the district could have at all been misinformed by the person collecting signatures to move the process to a vote, then how can their signatures be authenticated? Another resident responded stating the description of what they were signing was clear on the top of the petition. The first resident advised any good defense attorney would consider those invalid signatures. Supervisor Gott reminder the residents that Clerk Woodruff and Attorney Campbell would be reviewing every signature.

WHEREAS, the **Town of Livonia** desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of **Preliminary Engineering.** 

NOW, THEREFORE, the **Livonia Town Board**, duly convened does hereby

RESOLVE, that the **Livonia Town Board** hereby approves the above-subject project; and it is hereby further

RESOLVED, that the **Livonia Town Board** hereby authorizes the Town of Livonia to pay in the first instance 100% of the federal and non-federal share of the cost of **preliminary engineering** work for the Project or portions thereof; and it is further

RESOLVED, that the sum of **\$660,000.00** is hereby appropriated from the Town of Livonia and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the **Livonia Town Board**

shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the **Livonia Town Supervisor** thereof, and it is further

RESOLVED, that the **Supervisor of the Town of Livonia** be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the **Town of Livonia** with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further
