The Town Board meeting was called to order by Supervisor Gott at 7:00 PM. Jim Campbell led the pledge.

PRIVILEGE OF THE FLOOR

Supervisor Gott extended thanks and appreciation to Highway Superintendent PJ Dwyer and his crew for the weeding and mowing and taking care of the parks and cemeteries.

A Letter to residents of Conesus and Livonia was sent out from the Ambulance District and is posted on the Town of Livonia Website for viewing.

The Code of conduct policy at the Livonia Public Library is now in place.

Councilman Breu suggested that this year the Town Board budget for a new Dock at Vitale Park.

Councilman English advised that Moe has everything squared away for the 3rd of Julyand Councilman English has set up security with LCSO for the Third.

A resident asked about the proposed water project. The Board advised that the Map Plan and Report from Eric Wies is expected to be in front of the Committee in July. The resident questioned why this is being done again, if people voted no, initially. The Board explained that it wasn't necessarily voted down. The process in which the petitions were handled did not deliver a clear indication of the resident's interest. The hope is to handle the process in a more affordable way so that the residents that so desperately need water may get it. More to come on the Water Project in the coming months.

The Conesus Lake Association and the Chip Holt Nature Center both requested to purchase and place a shed in the park. The Town Board is in agreement as long as the programs purchase the shed to match the buildings currently in the park. The size, and placement of the sheds will be discussed in an upcoming meeting.

UPDATE ON AMBULANCE EMPLOYEES

Attorney Campbell has spent a lot of time working with the County on how to staff paramedics for the Ambulance. The good news is that this is possible legally and legitimately. True employees will only be employees of the Town, and not the ambulance. This is due to the Civil Service requirements. However, unlike most competitive positions, the exam is done by application and representation of experience. Attorney Campbell and the Head of HR, Kate Hill, discussed that where we are currently with various pools of potential employees, we would have enough to employ without becoming competitive. Another fact that needs to be considered and confirmed with the county, is that we can get workers compensation coverage. Keeping in mind that there is going to be costs that the ambulance may have not considered or had before, like health benefits, retirement etc. There are still details to iron out, but these discussions are heading in a positive direction.

Councilman Breu asked if they are off the clock can they still accept incentive fees. Attorney Campbell stated he thinks possibly but will have more information on that in the future. More to discuss with Matt Cicero and Scott Marshall and discuss further at the next meeting.
