A regular meeting of the Town Board of the Town of Livonia, County of Livingston and the State of New York was held at Vitale Park in Lakeville, NY on June 17, 2021.

The Town Board meeting was called to order by Supervisor Gott at 7:00 PM. Councilmember Breu led the pledge.

PRIVILEGE OF THE FLOOR

Barb VanZandt spoke and requested to hook up to Town Water while doing her upgrades at her home. Barb states that after review she needs approval from the Board, and the quote for the project has increased drastically. Supervisor Gott advised that the town has authorized income studies to be done to hopefully put water in on all her properties.

Mary Underhill presented from the Livingston County Watershed and reports with updates on the research taking place in the lake and tributaries, SUNY Brockport and SUNY Geneseo students are conducting the research. State boat launches are open and staffed and decontamination equipment is operational. Now have a drone, underwater camera and ROV. These resources help be proactive against invasive species in our waterways.

Councilmember English stated Mo Watson asked for the board to approve another camera, out by the road at Vitale Park. This will improve safety at the park considering recent incidents. The board would like to get information from the power company before approval to make sure this is possible.

Clerk Anderson reported she is fielding a lot of calls inquiring about Vitale Park being closed on July 3rd. Councilmember English discussed his concerns now that the restrictions have been lifted by the Governor. Supervisor Gott explains that if the park were going to be open for the third, the decision would have needed to be made sooner. Organizing an event of that size takes time, vendors such as the porta potty's, security

and most importantly staff. The board agreed that next year, this should not be an issue, and the plans can be made accordingly.
