A meeting of the Town Board of the Town of Livonia, County of Livingston and the State of New York was held at the Livonia Town Hall, 35 Commercial Street Livonia NY 14487

PRESENT: Eric Gott, Supervisor Joseph Breu, Councilmember Peter Dougherty, Councilmember Andy English, Councilmember Matt Gascon, Councilmember Hayley Woodruff, Clerk Jim Campbell, Attorney, Town of Livonia

OTHERS PRESENT: Several Residents.

The Town Board meeting was called to order by Supervisor Gott at 7:00 PM. Scott Marshall led the pledge of allegiance.

PRIVILEGE OF THE FLOOR

A resident expressed his continued concern about the amount of Livonia Fire District budget. The board expressed their agreement that the budget is high, however the fire commissioners did drop the budget roughly 25% from last year.

Scott Marshall expressed that the biggest concern for the Ambulance is the capital reserve, and asked the board if they could assist on that.

A member of the fire department added that a Fire engine twenty six years ago cost \$280k and the same exact truck today, with no added bells and whistles cost over one million dollars.

The board members stated it was time to start talking about a merger again, but the struggle is to get Lakeville on board. However they're essentially getting free emergency services as they're not paying adequate taxes, and Livonia is servicing all their calls.

DISCUSSION ON NEW PLAYGROUND AT VITALE PARK

Two residents came and proposed a new playground at Vitale Park. A plan was presented to the board with ideas and inclusion equipment. The park is currently operating with equipment from 1996. Supervisor Gott advised that the Town of Livonia has received a \$20,000 grant from the county. Moe Watson and Councilman English have been working on obtaining estimates and designs. The board did add money to the budget to assist on this project. The residents expressed that the deteriorating playground equipment is causing parents to have to go to other towns to take their kids to a safe

playground. They asked if the board was open to community and parent involvement in this project. The board accepted community input advised that this could still be a few year long project. Councilman English advised he has been in touch with Bears playgrounds who are significantly cheaper on the front end, for a nice setup; however the cost of maintaining the playground could be concerning. More to come on this project.

DISCUSSION ON WATER DISTRICT

Attorney Campbell advices that Eric Wies delivered the map plan and report for consideration at last meeting, he then met with the committee which resulted in minor refinements. Today, he delivered the final version of the map plan and report. The next step is by resolution is to accept the map plan and report so the subsequent steps necessary can be taken to move forward. Next step would be to move to public hearing. The map plan and report will be officially filed in the Town Clerk's office Friday 10/18/2024. He suggested a special meeting to schedule the public hearing, so that it could be at the November meeting. Saving the month could be preferable in regard to the funding process.

RESOLUTION 108-2024 In the Matter of the Formation of the Town of Livonia Central Livonia Water District and Construction of Water Facilities and Improvements Located Therein, Within the Town of Livonia, Livingston County, New York.

RESOLUTION

WHEREAS, the Town Board of the Town of Livonia is considering the construction of certain water delivery improvements within a new water district yet to be perfected and to be known as the "Town of Livonia Central Livonia Water District;" and

WHEREAS, the improvements are to be located in various areas through a portion of the Town of Livonia, County of Livingston and State of New York; and

WHEREAS, prior to completion of the improvements and the financing thereon, a district formation must be perfected to create the "Town of Livonia Central Livonia Water District;" and

WHEREAS, in order to facilitate the creation of the "Town of Livonia Central Livonia Water District" and the intended infrastructure improvements therein, the Town

Board adopted a resolution on March 13, 2024, authorizing the engagement of Clark Patterson Lee to prepare a Map, Plan and Report to provide the details of the improvements and the costs of such improvements to take place within the newly created district; and

WHEREAS, the cost of such Map, Plan and Report is intended to be borne by the district to be formed in which such improvements will be made; and

WHEREAS, Clark Patterson Lee has prepared such Map, Plan and Report with respect to the establishment of the "Town of Livonia Central Livonia Water District" and all improvements intended to be made therein and presented the same to the Livonia Town Board; and

WHEREAS, the Livonia Town Board now wishes to accept such Map, Plan and Report so that it may schedule a Public Hearing regarding the potential creation of the "Town of Livonia Central Livonia Water District";

NOW THEREFORE, be it

ORDERED by the Town Board of the Town of Livonia as follows:

- 1. That the Town Board of the Town of Livonia has been presented with the Map, Plan and Report for the "Town of Livonia Central Livonia Water District" as prepared by Clark Patterson and Lee and hereby accepts the same on behalf of the district to be formed; and
- 2. Any all costs associated with such Map, Plan and Report shall be passed on to the "Town of Livonia Central Livonia Water District" excepting and unless a valid petition is filed seeking a referendum pursuant to Article 7 of the New York State Town Law, in which case there will be a vote of all eligible persons within the district to be formed. Should the referendum result in the district not being formed, or should the district not be formed for any other reason, the cost of such Map, Plan and Report shall become an expense of the Town as a whole and shall be paid out of the Town's General Fund.
