LOCAL LAW #1-2021

3/10/2021

Village of Livonia, County of Livingston

A local law amending certain portions of Article 3 of the Code of the Village of Livonia, restricting certain vehicles on the Village highways and parking lots.

Section 1. Legislative Intent

It is the intent of this local law to prevent the use of the Village streets and parking lots by unlicensed, uninspected, or uninsured motor vehicles.

Section 2. Legislative Authority

This local law is enacted pursuant to the Village Law and General Municipal Law of the State of New York for the control and safety of the residents of the Village of Livonia with regard to motor vehicles on village streets and parking lots.

Section 3. Code changes.

Sections 142-14 and 142-21 of the Code of the Village of Livonia are hereby replaced and superceded in their entirety and replaced with the following provisions:

142-14. Certain vehicles restricted.

Any vehicle that is not properly licensed, inspected or insured is not permitted on any Village Street. Also, the parking of any truck, tractor, tractor trailer, trailer body, mobile home, house trailer, boat trailer, camper trailer, bus or any similar vehicle or piece of equipment is not permitted on any Village street or right-of-way at any time.

142-21. Certain vehicles restricted.

Any vehicle that is not properly licensed, inspected or insured is not permitted in any Village parking lot at any time. Also, the parking of any truck, tractor, tractor trailer, trailer body, mobile home, house trailer, boat trailer, camper trailer, bus or any similar vehicle or piece of equipment is not permitted in any Village parking lot at any time.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstances, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.
