WHEREAS, the Town Board of the Town of Livonia is considering the construction of certain sanitary sewer improvements within a new sewer district yet to be perfected and to be known as the "Central Livonia Water District," which had previously been referred to as the "South Livonia Water District;" and

**WHEREAS**, the improvements are to be located in various areas throughout the Town of Livonia, excepting within already existing Water Districts, all being located within County of Livingston and State of New York; and

**WHEREAS**, in order to facilitate the creation of the "Central Livonia Water District" the Town Board on July 27, 2022, duly adopted a resolution authorizing the engagement of Clark Patterson Lee to prepare a Map, Plan and Report to provide the details of the sewer infrastructure improvements and the costs of such improvements to take place within the newly created district; and

**WHEREAS**, adoption of the Resolution authorizing preparation of the Map, Plan and Report was subject to permissive referendum pursuant to Article 7 of the New York State Town Law; and

**WHEREAS**, the Town Clerk for the Town of Livonia caused a Public Notice of Resolution of the Town of Livonia Adopted Subject to Permissive Referendum to be duly published in the Town's official newspaper within ten (10) days of its adoption as required by New York State Town Law §90; and

**WHEREAS**, no petitions meeting the requirements of New York State Town Law §91 and New York State Election Law §6-140(1)(a) have been filed seeking permissive referendum with regard to the published notice; and

**WHEREAS**, the cost of such Map, Plan and Report shall be passed on to the "Central Livonia Water District" upon formation of said district. If such district is not formed, the expense incurred for the preparation of such Map, Plan and Report shall be a Town charge and shall be assessed, levied and collected in the same manner as other Town charges; and

**WHEREAS**, Clark Patterson Lee has prepared such Map, Plan and Report with respect to the establishment of the "Central Livonia Water District" and all improvements intended to be made therein and presented the same to the Livonia Town Board; and

**WHEREAS**, the Livonia Town Board now wishes to accept such Map, Plan and Report so that it may proceed with a public informational meeting and petitions regarding the potential creation of the "Central Livonia Water District";

#### **NOW THEREFORE**, be it

**RESOLVED** by the Town Board of the Town of Livonia as follows:

- 1. That the Town Board of the Town of Livonia has been presented with the Map, Plan and Report for the "Central Livonia Water District" as prepared by Clark Patterson and Lee and hereby accepts the same on behalf of the district to be formed; and
