Clerk Hay reminded the board that there were corrections made to the dog license revenue share that was supposed to go to the county because the software was not counting the purebred licenses. These corrections are reflected in the above report.

**Financial Report**

- Overall, we collected about \$400 more in revenue in 2014 over previous year. Most accounts only had minor changes. More significant changes were:
- Increases:
  - Hunting & Fishing license revenue was up about \$1,800.
  - We sold 44 marriage licenses, compared to 39 the previous year.
  - There were 13 Recreation Fees (\$3,900) compared to 6 (\$1,800) the previous year.
- Decreases
  - Zoning Fees were \$2,445 compared to \$4,105 the previous year.
  - Planning Fees were \$770 compared to \$1,395 the previous year.
  - Building Permits were \$13,303 compared to \$14,313 the previous year.

**Other Town Clerk**

- **Marriage Officer** - Clerk Hay performed ten weddings last year – some at the Town Hall and some at the parks or private residences.
- **Records Management** –
  - The scanning of burial and cremation permits is almost complete. Deputy Clerk Holt should be commended for the hours spent checking the scanned images to ensure that they were indexed correctly. She found an error rate of about 20%.
  - Corrections have been made and we should have the final electronic draft this week. We will check these for accuracy before they are burned to the waferfiche. At that time, we will release the final payment of \$600 for the waferfiche and request permission to destroy the paper.

- There are a few records which, because of their condition, could not be scanned. These will not be destroyed, but will be kept.
- We will do our own scanning going forward, and will wait until we have enough records to fill a waferfiche before sending them out to be converted. The ongoing cost should be \$200-\$250 per year, which will be covered under the \$1,000 Records Management line item in the Town Clerk budget.
- **Hunting & Fishing Licenses –**
  - The software vendor continues to make updates and improvements to the software. Most of the original issues have been solved.
  - Sales were up slightly over 2013. I think this is mainly due to the fact that not all agents were up and running at the start of sales.
  - The license paper continues to be an issue. We hope that in 2015 they are able to provide us with Valeron that will work in the license printers. We continue to use 2013 paper that we have on hand.
