

SPECIAL MEETING, TOWN OF LIVONIA

October 22, 2020

A special meeting of the Town Board of the Town of Livonia, County of Livingston and the State of New York was held at the Livonia Town Hall, 35 Commercial Street, Livonia on October 22, 2020.

The Town Board meeting was called to order by Supervisor Gott at 6:01 PM. Councilmember Gascon led the pledge.

Supervisor Gott explained that several meetings ago we appointed a committee consisting of Councilmember Dougherty, Attorney Campbell, Assessor Bennett, Supervisor Gott, Deputy Clerk Liesegang and Clerk Hay to recruit, interview and recommend to the Town Board a replacement for Clerk Hay when she steps into her new role on January 1, 2021. The committee thought it would be important to hire someone quickly because of the amount of responsibility in that office.

He reported that there were 72 total applicants, 20 of which were from Livonia. From this large pool of exceptional candidates, the committee selected several to interview. The committee recommends the appointment of Hayley Anderson as Deputy Town Clerk through December 31, 2020. Hayley will report to Clerk Hay until the end of the year.

The recommendation is to also pass a resolution appointing Hayley as Town Clerk starting January 1, 2021. The salary has already been set at \$40,500, which will be prorated for the remaining of this year.

Supervisor Gott shared that the committee was in 100% agreement in recommending Hayley for the position.
